Figure 1. UBL simple logo





Figure 2. UBL oval logo

# 2 Simple logo description and files

The simple logo consists of two elements: the globe in Nicosia globular projection with outlined continents, and the name of the committee "UBL".

The PNG files were created by exporting a bit image from scaling the SVG image.

The images have a transparent background behind the white globe halves. There are imperceptible off-white horizontal lines joining the top and bottom of the globe halves to allow for the outside of the globes to be filled with a colour without bleeding into the globes.




Figure 4. Simple colour pixel form in PNG format 154x100 pixels (24Kb)




Figure 8. Simple colour pixel form in PNG format 1838x1196 pixels (306Kb)




Figure 9. Simple bw vector form in SVG format (97Kb)




Figure 10. Simple bw pixel form in PNG format 154x100 pixels (23Kb)





Figure 14. Simple bw pixel form in PNG format 1838x1196 pixels (299Kb)




Figure 16. Oval colour pixel form in PNG format 154x100 pixels (33Kb)




Figure 20. Oval colour pixel form in PNG format 1838x1196 pixels (423Kb)




Figure 21. Oval bw vector form in SVG format (122Kb)




Figure 22. Oval bw pixel form in PNG format 154x100 pixels (32Kb)




Figure 23. Oval bw pixel form in PNG format 306x199 pixels (59Kb)
